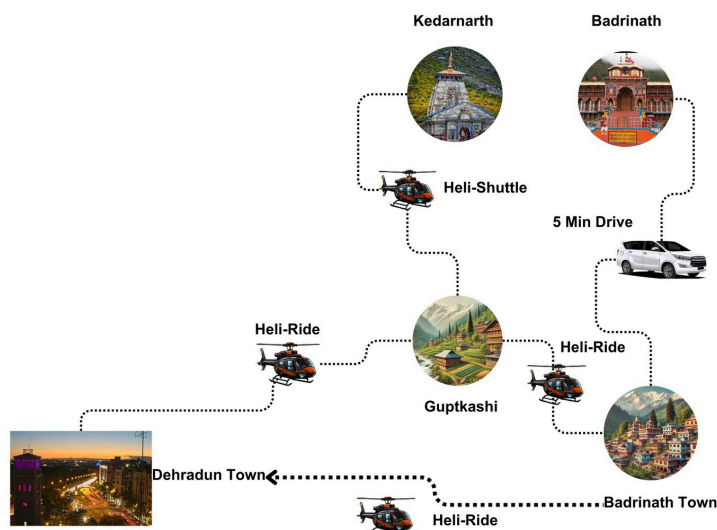

## DEHRADUN - KEDARNATH - BADRINATH - DEHRADUN

**KEDARNATH:** Kedarnath Temple, dedicated to Lord Shiva, it is one of the twelve Jyotirlingas and holds immense significance in Hindu mythology. Perched at an elevation of 3,583 meters (11,755 feet) above sea level, the temple stands amidst the majestic snow-capped peaks and is accessible through a scenic trek from Gaurikund. The serene Mandakini River flows nearby, adding to the spiritual ambiance. Every year, thousands of devotees and adventure enthusiasts visit Kedarnath to seek blessings, experience the tranquil environment, and witness the breathtaking natural beauty.

**BADRINATH:** Badrinath, a key pilgrimage site in Uttarakhand's Chamoli district, is one of the Char Dham and Chota Char Dham destinations. At 3,300 meters in the Garhwal Himalayas, it features the Badrinath Temple dedicated to Lord Vishnu. The temple, with its vibrant facade and conical roof, sits by the Alaknanda River and enshrines a black stone idol of Lord Vishnu. Surrounded by snow-capped peaks and legends, Badrinath offers a serene spiritual atmosphere.



# DO DHAM ITINERARY



## Day 1 - Arrival in Dehradun

Passengers should arrive at the State Government Helipad on Sahastradhara Road in Dehradun, which serves as the starting and ending point of this Yatra. Our pilots and ground staff will provide a briefing about the entire trip, including essential guidelines and instructions. This briefing will cover important information about the itinerary, safety measures, and any specific do's and don'ts to ensure a smooth and enjoyable journey.

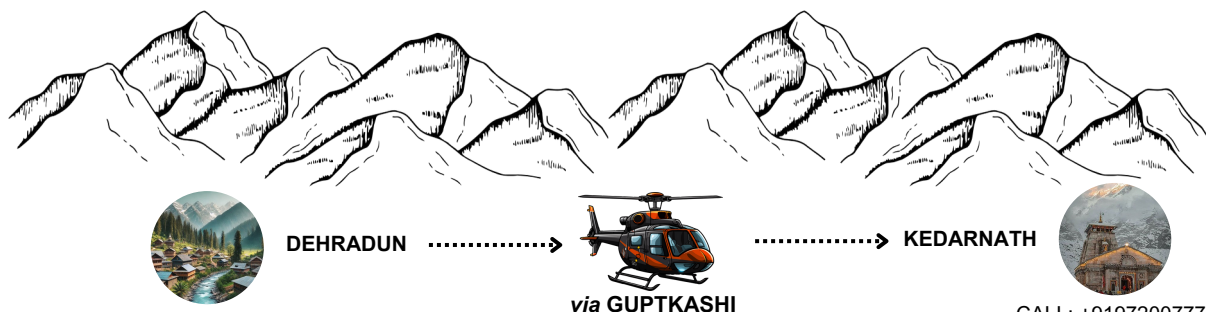
## DAY 2 : Dehradun-Kedarnath 07:45-08:30 - DDN-Guptkashi

After breakfast transfer you by road to Helipad (45 mins drive). On arrival at Sahastradhara Helipad, we fly to Guptkashi Helipad then again fly to Kedarnath from same Helipad. Temple is approx. 500 meters away from helipad and will take approx. 15 min to reach. Ground Staff will accompany the group and lead us to the VIP darshan in Kedarnath temple. After darshan and Poojan, The group will fly back to Guptkashi helipad. We will have lunch & Overnight stay at hotel in Guptkashi located at the banks of river Mandakini or Kedarnath dham.

**NOTE: Night halt at Kedarnath on triple and quad sharing basis on direct payment basis. The quality of accommodation available at Kedarnath Dham is just above average so passengers should not have very high expectations.**

## Day 3 - Arrival in Badrinath

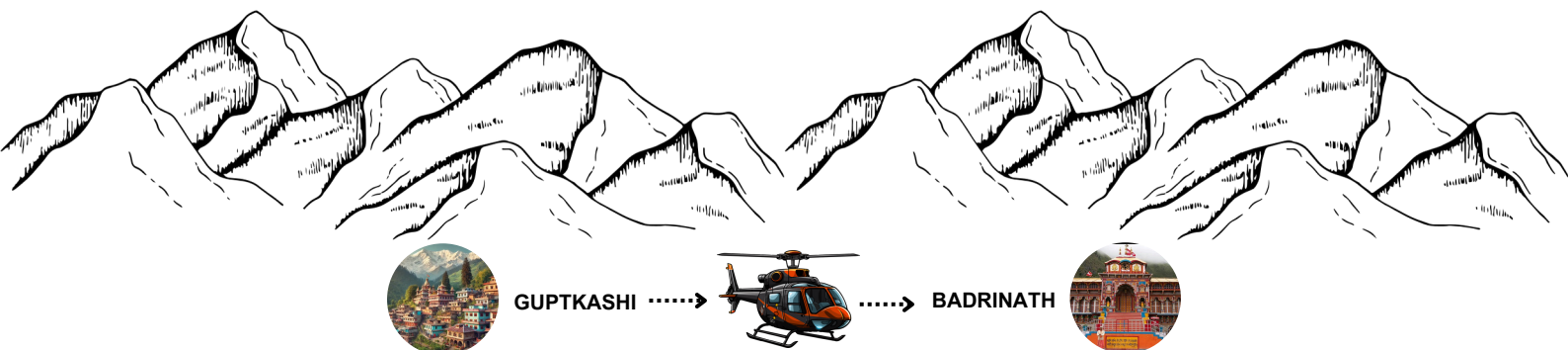
### 08:30-09:00 - Guptkashi-Badrinath

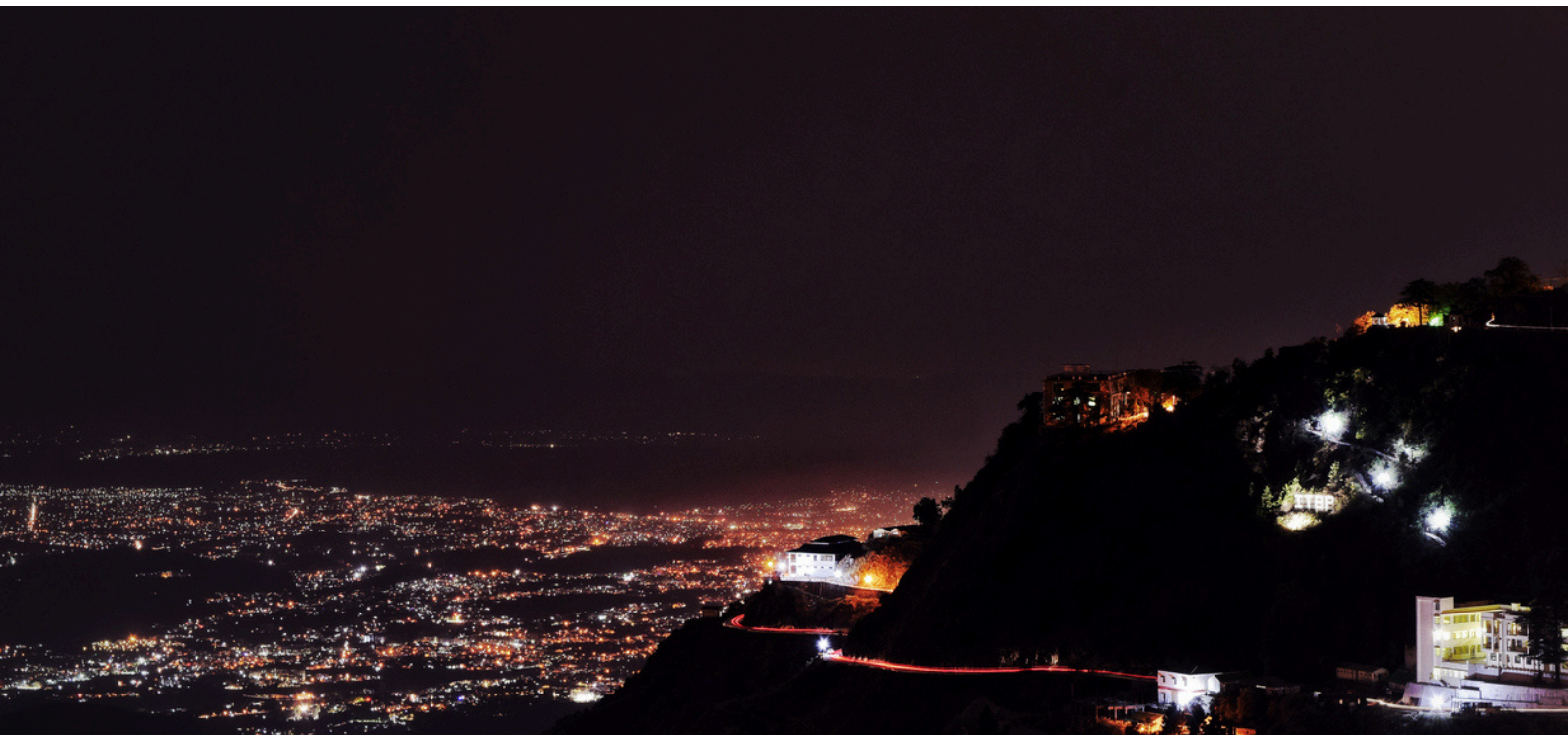

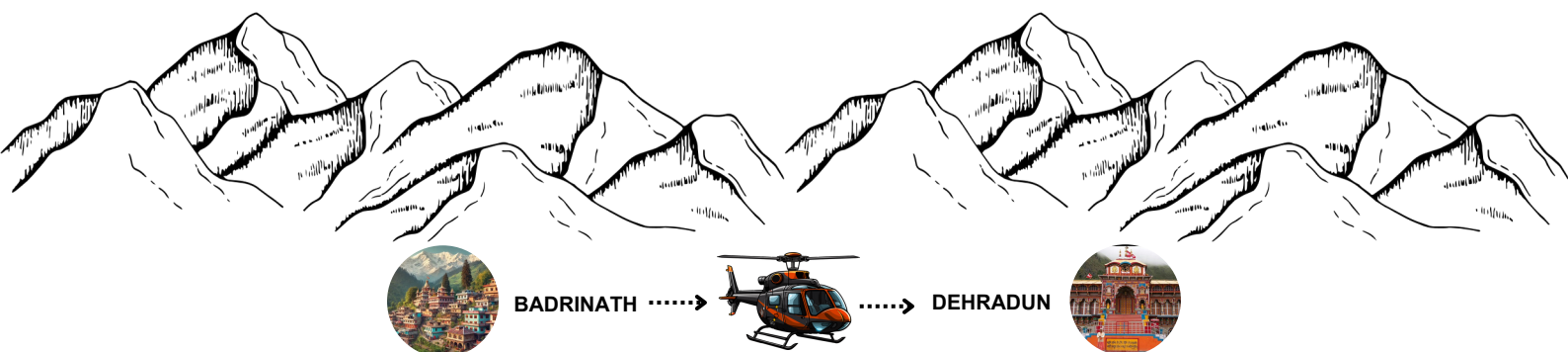


## Day 4 - Arrival in Dehradun 7:45-8:45 - Badrinath-Dehradun

# TERMS, CONDITIONS & GUIDELINES

## FIXED FLIGHT TIMINGS



This helicopter tour operates with fixed daily departure times for each destination. Passengers are required to adhere to the scheduled Estimated Time of Departure (ETD) for each day of the tour. Failure to do so will result in being marked as a NO-SHOW.

## PASSENGER'S WEIGHT



Passengers are required to provide their accurate weight at the time of booking. In the event of any weight discrepancy discovered during travel that exceeds our aircraft's weight capacity of 450 kg, affected passenger(s) will be de-boarded and the Heli-tour will be cancelled for them and without any refund.

Weighing at the time of boarding the helicopter is must since the pilot will not allow boarding in case it exceeds the weight conveyed at the time of booking & we reserve the right to shuffle passengers to manage the right weight of helicopters for safe flying in the hills.

## OVERWEIGHT CHARGES : PER SEAT BASIS ONLY



Excess weight charges for the Do Dham helicopter tour are fixed at INR 1250/- per kilogram, applicable to passengers whose weight exceeds 75 kg.

Moreover, if there is any variance in the passengers' weight, subject to charges based on the overweight criteria, the corresponding amount will be collected at the hotel before the day of flight boarding or at the helipad before the flight boarding.

## BAGGAGE ALLOWANCE



Only 2 Kg baggage per passenger will be permitted. Passengers are advised not to carry big suitcases as there is very small baggage space inside helicopter.

## INFANT



Children above the age of 2 years will be considered full ticket. Infant below 02 Yrs. /12 Kg are carried free of charge. In case of verification of age, ID proof (Birth certificate) of the child shall be checked.



# TERMS, CONDITIONS & GUIDELINES

## BAD WEATHER AND FORCE MAJEURE DISCLAIMER



Helicopter flying in hilly terrains are adversely affected by some unpredictable factors such as adverse weather conditions and various Force Majeure events. These include delayed Air Traffic clearances/Permissions, VVIP movements, valley flying by the Indian Air Force (NOTAM), sudden technical issues in the aircraft, illness of the flying crew, or delayed reporting of passengers at the helipads, among other unforeseen circumstances. Passengers are advised to be prepared to encounter any unexpected events and inconveniences that may arise in such scenarios.

**Note :** When planning your tour, we strongly advise the guests to keep one additional day at hand at Dehradun, so that they do not end up in problem in case the weather gets very bad after the commencement of tour, which may lead to extension of the tour.

## COVID TRAVEL GUIDELINES



Passengers and Cloud 9 Helicopters must strictly follow COVID protocols in accordance with the prevailing government mandates. Non-compliance with Government guidelines may result in the denial of boarding to passengers, and refunds will not be provided in such cases.





## ADD-ONS

### **Maha Abhishek Puja at Badrinath ji – INR 4,700/person.**

Total amount has to be paid in cash to SBTM Representative at Dehradun, so that we can arrange and book the Puja in advance on behalf of each passenger. Note – Maha Abhishek Puja will not be included in our package or billing cost, since the total amount for the same goes directly to Badrinath ji Mandir Samiti.

### **Rudra Abhishek Puja at Kedarnath ji – INR 6,500 for 05 people.**

Total amount has to be paid in cash to SBTM representative at Dehradun, so that we can arrange and book the Puja in advance on behalf of each passenger. Arrangement of Rudra Abhishek puja will be done subject to availability of rooms at Kedarnath-Top, as passengers will have to stay there overnight for the puja. Therefore, the additional charges towards the hotel stay will be extra chargeable.

Note – Rudra Abhishek Puja will not be included in our package or billing cost, since the total amount for the same goes directly to Kedarnath ji Mandir Samiti.

**Disclaimer** – Accommodation at Kedarnath-top is budget category, and there can be instances of complaints in regards to the hotel services & rooms. Furthermore, temperature at Kedarnath-top may drop to sub-zero levels at night in Sep/Oct; therefore passengers are advised to take decision keeping the same in consideration.

### **Booking of Scheduled/Non-Scheduled Flights or Train Tickets: Price on demand.**

While our team takes care of your entire Do dham tour, they can also assist you in booking of air/Train tickets to Dehradun.

### **Haridwar, Rishikesh or Mussoorie day-trip:**

INR 8000 for up to 06 passengers on your date of arrival or departure, our team can arrange transportation for Mussoorie, Rishikesh or Haridwar day-trip from Dehradun.

### **Extra night stay at Dehradun**

Price on demand for additional night stay at Dehradun, our team will take care of your hotel bookings. FYI, we arrange hotels at the most attractive rates you can get.

### **Hotel /Airport transfers: We arrange pick-up/drop services for our passengers at Dehradun.**

- Jolly grant Airport pick-up & drop) = INR 7,000 (both-way). Hotel to Helipad & Helipad to Hotel
- Pick-up & drop (Within Dehradun) = INR 3,000 (both-way).

**CARRIAGE BY AIR ACT, 1972** The carriage is subject to Cloud 9 Helicopters Services regulations relating to the conditions of Non- International Carriage (Passenger and Baggage) framed in accordance with The Carriage by Air Act, 1972 and Notification regarding application of the carriage which is non-international. The liability of the company for damage sustained in the event of the death or wounding of a passenger or any other bodily injury suffered by passenger or by his registered baggage during the course of carriage by air will be governed by the provisions of sections 4,5,6 and the rules contained in the second Schedule of Carriage by Air Act 1972 with certain exceptions, adaptations, modifications, etc has notified in the Govt. of India, Ministry of Civil Aviation Notification and as amended from time to time.



## OTHER TERMS & CONDITIONS

- AADHAR Card copies are to be shared by all Indian passengers, & passport in case of foreign nationals.
- Any donations, tips, pitthu, palki/pony and porter charges shall be borne by the passengers. Cloud 9 Helicopters has its own crew at all the Dhams. For any guidance or assistance, Passengers are free to reach out to them.
- Network connectivity at Harsil & Badrinath is very poor. BSNL & Jio are the main telecom services that work in these regions mostly, but not always. However, our staff shall be with the passengers for assistance at all times.
- Passengers are advised to carry a small oxygen bottle with them as a precaution. It is available locally at all medical shops.
- Although day temperatures at these locations are normal it becomes cold in the night and so passengers must carry woolen clothes with them. All passengers are advised to carry their own medication.
- We would like to inform our pilgrims that we do not provide insurance coverage for accidents, sickness, loss due to theft, or any other unforeseen circumstances. Therefore, we strongly recommend that pilgrims make their own arrangements for insurance coverage.
- Please note that all baggage and personal belongings are solely the responsibility of the client at all times.

### MEDICAL EMERGENCIES



Company shall not be liable for any medical emergency on the ground to the party, thus advised guests to get the fitness certificate from doctor to travel to the high altitude sector. The Company reserves the right to refuse to carry any person whom it considers unfit for travel or what in the opinion of the company may constitute risk to the aircraft or to the persons on board. No refund shall be done to such passenger(s).

### RESCHEDULING OF BOOKING



Rescheduling of booking to a next date will be done subject to availability and on payment of 20% of the cost. This will be permitted only if applied 15 days before journey date. In case the rescheduling is requested with less than 15 days to the journey then booking will be treated as cancelled and a fresh booking will be given subject to availability.

### PAYMENT TERMS



- Package Confirmation & Booking, please deposit the 50 % amount of the Tour cost to process the booking and the balance amount is to be paid 15 days before from your departure dates.
- Passengers are only allowed to board or initiate the tour after completing the full and final payment for the tour.



## OTHER TERMS & CONDITIONS

### CANCELLATION POLICIES:

If passengers wish to cancel their booking, then they will have to pay following cancellation charges

- Up to 30 days before journey - 30% of amount
- Up to 20 Days before journey - 50% of amount
- Up to 14 Days before journey - No Refund
- No Show – No Refund

### FORCE MAJEURE AND BAD WEATHER REFUNDS:



If flying is not possible due to any reason/bad weather at Dehradun, then 5% Service charge will be applicable.

### BAD WEATHER & FORCE MAJEURE POLICIES:



In the event of flight cancellations or delays due to bad weather, technical issues, or any force majeure reasons beyond the control of the company. Cloud 9 Helicopters will not be held liable for the cancelled or delayed flights. However, refund will be given to the client as per our refund policy. No compensation or reimbursement for accommodation, transportation, meals or any other extra travel expenses done by the guests will be provided in the event of cancellation of a flight.

In case, the departure does not take place from Dehradun due to any above mentioned reasons, the tour will be considered as cancelled and refund will be made as per our policies.

However, in this case guests are open to reschedule the tour for the next available date; a fresh booking can be made for the same. Our team will propose the available option to the guests.

The remaining or unused amount from the previous booking can be applied towards the fresh booking. Any additional costs incurred will be the responsibility of the passengers.

Any extension, proposed by the passengers, in the package will only be considered at an extra cost and subject to operational viability.

Additional night halt charges will be payable by the passengers to hotels on direct payment basis, when they get stuck for additional nights due to bad weather/force majeure reasons.

In regards to the guests stranded at any Dham, if any group requests to cancel their tour on their own desire & come down before their scheduled return date, the arrangement of vehicle for their return journey by road shall be done by us, however, cost for the same shall be borne by the guest on direct payment basis. No refunds are applicable in case guests wish to cancel & return mid-tour.
